Andy Schwab, Ag Broadcaster Northern Ag Network

Andy Schwab grew up in Powell, WY on a small farm that produced race horses while he was a kid. He learned to ride horses, hunt, fish and take pack trips to the backcountry



at very young age and has yet to lose the passion. Through his high school years at Powell, Andy competed in sports, FFA and started his own farrow to finish hog business. He would add many hats to wear after graduation as he jumped right into the work force, often times holding two to three jobs at a time. For nearly 10 years his main vocation was working in the retail world for a local co-op and farm and ranch store.

In that time, he would also add job experiences from the Wyoming Game and Fish as an AIS Tech and the US Forest Service as a backcountry trail crew foreman, spending three seasons with each department. He also became a bar tender for a local steakhouse in Cody, WY for three summers to prevent any boredom from setting in. But probably his favorite hat he put on was that from an auction business he started on his own and continues to operate after self-teaching himself how to be an auctioneer. "It's the one job that has taught me how to use my voice properly, and opened a lot of new doors, including the door to Northern Ag Network and sports broadcasting."

In May of 2019, Andy joined the Northern Ag Network as an Ag Broadcaster and one of his first interviews on air was with the Governor of Wyoming, Mark Gordon, while attending a mid-year conference held by Wyoming Stock Growers Association. Andy has since interviewed several more Governors from the Northern Ag territory, along with many other leaders and industry experts.

Lyle Myler, Area Manager Bureau of Reclamation Wyoming Area Office

Lyle Myler received his degree in Civil Engineer with an emphasis in Water Resources from the University of Wyoming. Since that time, he has been employed by the Bureau of Reclamation's Wyoming Area Office located in Mills, Wyoming. Mr. Myler has 32-years of experience working for Reclamation in Wyoming and has been involved in reservoir operations and delivery of water to about 600,000 acres of irrigated lands, land and recreation management, Safety of Dams activities, and operations of 11 hydropower plants in the North Platte and Wind/Bighorn River Basins. Since April 2022, Mr. Myler has served as the Area Manager for Reclamation's Wyoming Area Office.



WHY WE TRIM TREES

The majority of power outages are caused by tree-related issues. It is our job to ensure trees, branches and limbs are a safe distance from power lines to avoid fire hazards and power interruptions.





Energy Efficiency Tip of the Month

Do you have a home office? Set equipment like printers and scanners to automatically switch to sleep or energysaver mode when not in use. In addition to saving energy, the equipment will stay cooler, which will help extend its life.

Another way to save in the home office is to use energy efficient lamps for task lighting. Small lamps use less energy than whole-room lighting.



Do not trim trees/branches within 10 feet of a power line or pole. Only certified line clearance tree trimmers are authorized to trim near power lines. Safe Electricity.org*

TRAIN OTHERS

Train anyone working on your farm, including family members and seasonal workers, about electrical hazards.

REMEN

SAFETY FIRST

Have daily meetings to review the day's work and discuss safety implications. Know and review where the power lines are, the clearance required, and the proper position of extensions as they are transported.





WAIT TO UNFOLD

Remind workers to fold or unfold extensions well into the field, not close to the field's edge where power lines are typically located.

USE A SPOTTER

When working in the vicinity of power lines, always have a spotter on the ground, who can direct you away from power lines or poles if you are getting too close.





DO NOT EXIT YOUR CAB

If your machine or truck makes contact with a power line, pole, or guy wire, you could become electricity's path to ground and become electrocuted if you step out of the cab.

CALL 9-1-1

Call 9-1-1 to have your electric utility dispatched to deenergize the power source. Only exit the cab is if your equipment is on fire. If that happens, make a solid jump out and hop away with feet together as far as you can.
